NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES THAT:

1- Raj Malhotra's IAS of ARJUN will conduct the training program in the campus of MCM for the student of MCM:

Program Details:

1. This Course is meant exclusively for the student of MCM DAV College Only and no outsider shall be eligible for the same, under any circumstances, whatsoever, unless asked by the college management under their warrant and seal.
2. The course shall be three/two/one year duration, depending on the academic year of the student concerned.
3. The Fee shall be same for the courses irrespective of the course duration and every student shall be entitled to continue till the time they are satisfied, even if it means to join the other branch of Arjun or to claim on-line courses.
- 2- ARJUN shall provide necessary training materials to the participants and also ensures timely completion of training program.
- 3- MCM shall provide necessary infrastructure such as auditorium/open space to conduct the training program

5- Payment:

 - f) For providing the logistics / Infra. We shall share 30% of the fee (after tax deductions) with your organization.
 - g) Besides that, as part of our **CORPORATE SOCIAL RESPONSIBILITY** ,we stand committed to :
 - 100% fee waive to economically weaker students.
 - Complementary notes, test series and standard text books to all.
 - 50% off for Single – parent (Mother) child.
 - 50% off for only Girl child
 - 10% off for SC/ST/BC/OBC.
 - 25% off for college toppers
 - 25% off students from Defence background/ families
 - 25% off for kins of freedom fighters.
 - 100% off to kins of Martyrs/disabled while in service


