In response to this question, the institution sent the following data:

However, this was revised by the DVV partner as under, stating that “Values have been changed considering only scholarships and Fee concession for AY 2020-21 and 2019-20. In other years HEI has clubbed Cash Prizes with Scholarships which need to be separated by HEI to avail the claim.”
