

Report of the Theft Case by Student Redressal Cell

A case was handed over to the student Redressal Cell on 12.04.2022 regarding a theft in the Library Locker room. There was a theft where valuables (Cash Rs. 2000 - , 3 makeup items and one locket were stolen from the bag of the complainant [REDACTED] on 5th April, 2022 between 9:30-11:00 in the morning. She accused two girls [REDACTED] who were present at the same time in the locker room which can be clearly seen through the CCTV footage. The two girls (who were accused by [REDACTED]) said that they came to know about such theft incident on 7th April, 2022. A meeting of the Redressal Cell members was held in 13th April, 2022 after the case was handed and the cell started its investigations thoroughly. Both the complainant and respondents were called by the cell members on 17th April, 2022. Both parties put forward their arguments and written letters were taken from them. It was seen in the CCTV footage that the respondents [REDACTED] spent a lot of time in the Locker room which was quite unusual. But no conclusive evidence can be drawn. The Cell has advised students to be more careful and take care of their valuables. To avoid such thefts, the students should be more alert and not leave their valuables unattended.
